
message from the executive director

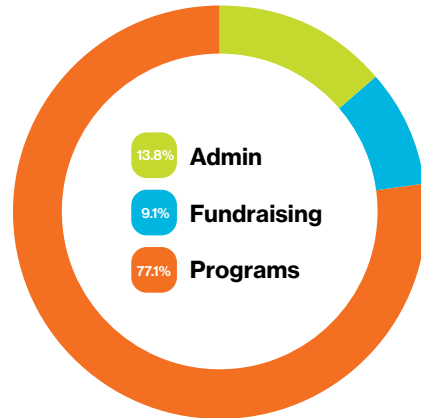

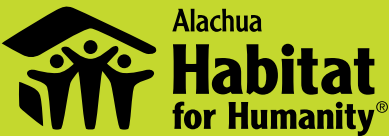
